Conservation and Access: American Whitewater's core mission-related work is the conservation, restoration, and responsible management of whitewater rivers. In 2015 American Whitewater directly participated in management decisions that improved flows and river access associated with dams on at least 25 rivers across the country. American Whitewater advocated for new Wild and Scenic River protections on well over 100 rivers across the nation, and helped secure protection for 2 new "eligible" Wild and Scenic stream reaches in Montana, the designation of the Browns Canyon National Monument, and passage of the Clean Water Rule. American Whitewater secured new and/or improved river access areas on 12 streams in CA, CO, MD, NC, OR and WA. American Whitewater collaboratively managed river access on at least 16 rivers. All told these efforts benefited several thousand miles of spectacular rivers, and hundreds of thousands of river enthusiasts.

Public Education: American Whitewater educates the paddling community, general public, federal agencies, and decision makers on river stewardship issues and opportunities through several outlets. American Whitewater maintains and posts weekly content on the go-to website of the paddling community, with almost 1 million unique visitors and almost 9 million page views last year. Our website features news, action alerts, and descriptions of over 5,000 whitewater river reaches. In 2015, we negotiated the installation of 1 new stream gage that is shared on our website. The organization also reaches over 15,000 people through action alerts and monthly e-mail newsletters, and regularly posts to a Facebook page with over 24,000 followers. American Whitewater's roughly 5,400 members and over 100 affiliate clubs receive our print Journal published 5 times per year. American Whitewater shared river conservation and access content at over 15 events, and over

50 public meetings in 2015. In addition American Whitewater offered educational volunteer opportunities that resulted in members spending several thousand hours volunteering for our organization in 2015.
