





The Montana Headwaters Legacy Act is introduced and ready to be moved forward through Congress and become law. This bill, a 10 year project for American Whitewater and our partners will designate 20 new Wild and Scenic Rivers north of Yellowstone National Park. 
Eight months ago, dams and removal did not get a mention in the infrastructure proposals from the White House or either party. With much hard work from American Whitewater, our conservation partners, and the hydropower industry, the legislation in Congress now contains \$2.6 billion to rehabilitate, retrofit, and remove dams across the country. The draft Grand Mesa, Uncompahgre, and Gunnison National Forests plan revision is out and we're working to ensure that protections for healthy, free-flowing creeks and rivers make it across the finish line in the Final Plan, which will be released in the Spring of 2022. As we move into a hotter and drier future, we are fighting for legal protections for water in rivers - through expanded water rights in Colorado - and our access to it - through a court case in New Mexico.
